COUNTRY BRIEF

Haiti was included in the United Nations' 2020 COVID-19 Global Humanitarian Response Plan (GHRP).

On 19 March 2020, Haiti declared a state of health emergency across the country. The latter is extended until 11 July 2020. The following measures have also been adopted:

- A national curfew from 8 p.m. to 4 a.m. is in place;
- Educational establishments, places of worship and factories are closed;
- Meetings of more than ten people are prohibited;
- The use of masks in public is compulsory.

AIRPORT STATUS

1. Airport / Flight restrictions

Flights to Port-au-Prince (PAP) and Cap-Haitien (CAP) are suspended. This does not apply to:

- Cargo flights;
- Domestic flights;
- Emergency flights;
- Humanitarian flights;
- Medical evacuation flights:
- Government flights.

The operations of the United Nations Humanitarian Air Service (UNHAS) continue.

Dominican Republic:

- Commercial flights to and from the Dominican Republic are suspended;
- Cargo flights from and to the Dominican Republic continue normally;
- International flights are only allowed for ferry operations and the repatriation of foreigners.
- Exceptional permits must be requested from:

2. Passengers / Quarantine

The border with the Dominican Republic is closed to passengers. (Information dated 16 March: UNECE)

The Ministry of Public Health checks all international travelers at airports before processing immigration.

(Information dated 3 May: IATA)

There are currently no known restrictions on people seeking to leave the country, with the exception of the border closure with the Dominican Republic. (Information updated 28 May: International SOS)

IMPORTATION AND CUSTOMS

3. Customs, land, sea

The land border with the Dominican Republic remains open in Dajabon for the movement of humanitarian cargo ships, accompanied by sanitary controls and the prior approval of the Customs authorities. The other entry points are closed. A slowdown in truck movements has been reported in the Dominican Republic.

Cargo ship operations are proceeding normally.
