# Item 1: Opening and adoption of the agenda

1.1 The Chair of the Working Party, Mr. Fredrik Zetterquist, opened the meeting and invited the bureau to make any amendments to the previous bureau meeting minutes and then to the agenda. No amendments were introduced.

### Item 2: Debrief on past events and status on actions

<u>Capacity building and international knowledge sharing:</u>

- 2.1 Joint WPLA/CLRKEN workshop in Lausanne, 21 April, 2017: There was lowered participation in the workshop as compared to others in the past. It was suggested to perhaps not do the meetings in parallel but rather back-to-back.
- 2.2 PCC workshop in Malta, 5 May, 2017: Roberta Marconi and Rik Wouters attended. There was a land registry component to the meeting, which is typically focused on cadastre.
- 2.3 FIG Working Week in Helsinki, 29 May-2 June 2017: Chryssy Potsiou thanked Fredrik Zetterquist for WPLA's participation and keynote speech and the Finnish

- organizers. There were approximately 1,150 participants at the conference. There has been some restructuring of FIG.
- 2.4 UN-GGIM: Europe 4th Plenary Meeting in Brussels, 7-8 June 2017: No members attended the meeting but Chryssy Potsiou will attend the upcoming meeting in NY and will represent WPLA in the EG-LAM. The secretariat will send her a summary of activities to present.
- 2.5 Preparation for the joint CVC workshop in Vienna, (BEV building 8<sup>th</sup> floor), 5-6 October 2017: the invitations went out mid-June and the draft agenda was sent to the bureau for inputs. Please send all proposals for speaker to Julius Ernst. There will be a welcome address from each of the organizers.

#### Land administration reviews:

- 2.6 Government request from Belarus and Bulgaria: Awaiting funding for the Belarus country profile and in discussions with Bulgaria regarding funding for their country profile.
- 2.7 Elaboration of template for the LA reviews: the secretariat will follow-up with Peter Creuzer to see what is the status of the guidance document.

#### Studies:

- 2.8 Questionnaire on land administration systems: Many of these are covered by the WB's Doing Business report and a scoping exercise needs to be done to evaluate the need. See what is available from OECD and the WB (e.g. The Land Governance Assessment Framework).
- 2.9 Informal settlements: Rik Wouters drafted the workplan for the task group on the technical guidelines for informal settlements. The secretariat will update it considering the timeline and availability of resources.
- 2.10 Land consolidation: Rik Wouters will discuss with Walter de Vries from TUM (Tech Uni Munchen), FAO (Morten Hartvigsen) and Dutch Kadaster (Marije Louwsma) the official partners about collaborating on a study on land consolidation in the UNECE region. A task group has been set-up for this end.
- 2.11 Scenarios for future land administration and management: A task group has been set-up for this topic.

## **Item 3: Strategic issues**

- 3.1 Collaborations with other organizations:
  - a. Fredrik Zetterquist discussed his meeting with CLGE to discuss ILMS and Howard Bushell will set up a meeting with James Kavanagh from RICS to discuss collaboration. Fredrik to send a summary of that meeting to Howard.
  - b. The WPLA is encouraged to think about what kind of contribution they would like to make for the CHLM 70<sup>th</sup> anniversary to be held in November 2017.
  - c. Place on the agenda of every bureau meeting the topic of future scenarios of land administration systems.
  - d. There is a need to discuss future scenarios in the framework of how organizations can collaborate.

- e. Tatjana Cenova discussed using the regional cooperation in the western Balkans. The 10th Regional conference on cadaster was held in the period 8 9. June 2017 in Skopje, The Former Yugoslav Republic of Macedonia, to utilize these conferences to promote collaboration.
- f. The secretariat to send the list of custodians of the SDGs to the bureau in order to evaluate what collaborations can be made.

- g. The <u>WPLA brochure</u> should be revised. The secretariat to send out the <u>Social and Economic Benefits of Good Land Administration 2005</u> in order to see if some of the text can be reused. Howard Bushell would take the lead in look at different options for the new brochure.
