## Item 1: Opening and adoption of the agenda

1. The meeting was opened by the Chair of the Working Party, Mr. Elshad Khanalibayli. The Bureau adopted the agenda without amendment.

## Item 2: 77th CHLM Session WPLA, 13-14 September 2016

- 2. The <u>Land administration and management session</u> was held on Wednesday, 14 September 2016, in Room XVI.
  - a. The activities of the WPLA were presented by Mr. Elshad Khanalibayli; proposals for the organization of the Working Party Tenth session in March 2017 by Ms. Amie Figueiredo; Information on the progress of a study on advantages and disadvantages of unification of land registries and cadastres by Mr. Rik Wouters.
- 3. Meeting of WPLA/REM Cooperation was held on 14 September 2016 in Room S-436: Discussion and approval of the workplan both by the WPLA Bureau and REM. Mr. Rik Wouters to send out summary and next steps.

  - a. Some ideas for the 2018-2019 PoW are topics in:

- i. Efficiency in land use
- ii. Study on land consolidation; land fragmentation perhaps jointly with FAO.
- 6. Final versions of official documents for the Session must be submitted 6 December 2016, the documents must be reviewed and formatted by 29 November. The Bureau must give latest comments by the Bureau meeting 23 November.
- 7. There will be the election of new Bureau members and Chair at the 10<sup>th</sup> Session. The Secretariat will send out a reminder for Bureau members to request nominations from their respective agencies. Once these nominations are received, the secretariat will contact their Missions in Geneva for their support.
- 8. Members of the current Bureau:
  - i. Mr. Elshad Khanalibayli (Azerbaijan) will step down as Chair.
  - ii. Mr. Markku Markkula (Finland) and Ms. Pia Højgaard (Denmark) will not seek re-election.

- 9. Nominations for new Bureau members: Norway will nominate Elena Busch; Switzerland and the USA have expressed interest in joining the Bureau. Looking for a new Chair.
