ESTABLISHMENT OF UNITED NATIONS GLOBAL TECHNICAL REGULATION No. 21

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 11 November 2020, at its fifty-ninth session, the Executive Committee of the Agreement established the following draft United Nations Global Technical Regulation in the United Nations Global Registry, under the symbol ECE/TRANS/180/Add.21, by consensus vote (ECE/TRANS/WP.29/1151, para. 136), in accordance with para. 7.2. of article 7 of Annex B to the Agreement:

United Nations Global Technical Regulation on the determination of Electrified Vehicle Power (DEVP) (ECE/TRANS/WP.29/2020/125).
