

**Draft Minutes of the 7<sup>th</sup> meeting of the Task Force on Studded Tyres  
October 12, 2021 starting at 3:00 pm ending at 5:00 pm CET**

1. Welcome and introduction
  - Attendance list is attached to these minutes
2. Adoption of the agenda
  - Agenda was adopted
3. Approval of the minutes from 6<sup>th</sup> Task Force meeting on Studded Tyres (TFST 06-03)
  - Minutes were approved
  - Chair informed that meeting between ETRTO and Traficom was not yet scheduled from ETRTO request
  - Secretary had not asked GRBP Secretariat about the “fast track” option after the process information offered at the previous GRBP
4. A proposal to be provided for the 75<sup>th</sup> GRBP session
  - A proposal for an amendment, introducing the ice grip marking into the New Regulation
    - Secretary presented the updated draft Working Document amending the new UN Regulation:
    - Elements of Ice grip taken from the GRBP adopted Working Document amending the Regulation 117, some details added reflecting the testing with studded tyres, in line with the ISO 19447
    - Grammatical corrections and alignment done according to the GRBP adopted Working Document amending the Regulation 117
    - Hierarchy of symbols was implemented according to the proposal of ETRTO (=ice is a sub-group of snow)
    - The group agreed with the draft after minor changes but there was a pending question whether Traficom may accept the hierarchy of symbols and it was agreed that Chair checks the Traficom position:

## Task Force on Studded Tyres (TF ST), 12 October 2021

- a. If Traficom agrees with the draft, it shall be sent to GRBP Secretariat (before the deadline Nov 15, 2021) and the preliminary meeting slot of October 25, 2021 may be cancelled.
  - b. If Traficom does not agree with the draft, the preliminary meeting slot of October 25, 2021 will be held and the meeting used to search for a solution to the draft Working Document.
- There was also discussion about the preferred project time line. The group agreed that it is important to allow the use of the new Snow Grip Marking for Studded Tyres, for which reason the group was not in favour of asking to postpone the WP.29 consideration of it from March 2022 to a later stage.
