

**Draft Minutes of the 8th meeting of the Task Force on Studded Tyres
October 25, 2021 starting at 2:00 pm ending at 4:00 pm CET**

1. Welcome and introduction

 - Comment from Traficom
 - Traficom had communicated that it can accept the proposed draft Working Document
 - Comment from ETRTO
 - ETRTO had communicated that they had found a potential issue regarding the Regulation 117 and Ice Grip Symbol and therefore wished to put on hold the proceeding with the new UN Regulation and Ice Grip Marking until they had assessed the potential issue in Reg. 117. ETRTO therefore also asked to maintain this preliminary meeting slot for discussing the topic.
 - ETRTO had prepared a presentation introducing the potential issue in Reg. 117. A discussion was held on the potential issue and some details were corrected in the presentation. Chair and Secretary of the Task Force did not agree with ETRTO that the process of the new UN Regulation should be put on hold because of a potential issue in another Regulation (117). It was nevertheless agreed to offer ETRTO the time for further assessment and that the Chair will inform the GRBP Chair and Secretariat about the postponement. It was agreed that a new target is set to submit the Working

Document in June 2022 for the September 2022 GRBP meeting.

- ETRTO further proposed certain corrections to the draft Working Document which were agreed upon.
- It was also agreed that the Chair will circulate a draft Status Report when approaching the February 2022 GRBP meeting.
