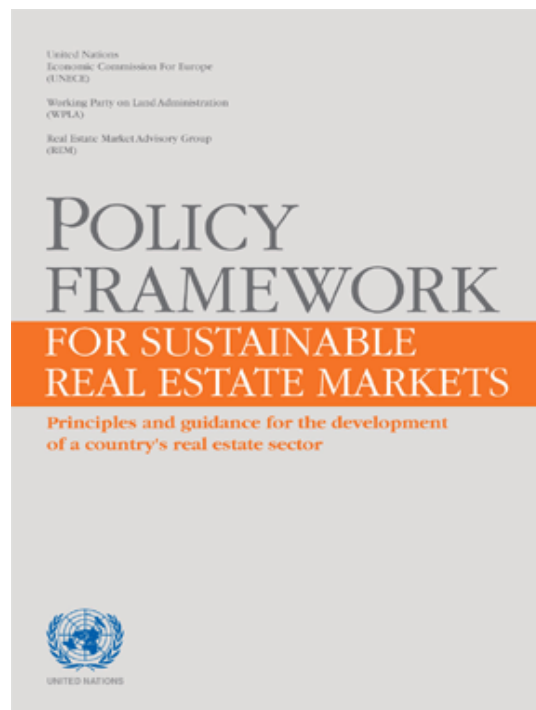
Programme

The United Nations Economic Commission for Europe (UNECE) has recently released a document to serve as a support tool to the member States to promote rules framework for the development of economic and real estate sector so to minimize the present financial crisis. UNECE/REM event, organized by Tecnoborsa in cooperation with FIABCI, Federimmobiliare and Confedilizia will introduce and explain the Italian version of *Policy Framework for Sustainable Real Estate Markets: Principles and Guidance for the development of a country's real estate sector*.

In this occasion they will be also produced the hopeful results achieved in such nations as Ukraine and Portugal where took account of *Policy Framework*.

Starting from the Principles of UNECE/REM's document the comparison aims to offer in Italy an overall consideration on legal framework so to make the real estate sector more efficient, competitive and even more attractive to foreign investors so to contribute to the Country's economic and social development.

The target is to search, in an holistic approach, some inputs to have a more efficient and competitive sector, able to drive the recovery, with social and economic benefit of the Country and of the private sector itself.
