ESTABLISHMENT OF AMENDMENT 1 TO UNITED NATIONS GLOBAL TECHNICAL REGULATION No. 22

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 26 June 2024, at its seventieth session, the Executive Committee of the Agreement established the following amendment in the United Nations Global Registry, under the symbol ECE/TRANS/180/Add.22/Amend.1, by consensus vote (ECE/TRANS/WP.29/1179, para. 170), in accordance with para. 7.2. of article 7 of Annex B to the Agreement:

United Nations Global Technical Regulation on In-vehicle battery durability for electrified vehicles (ECE/TRANS/WP.29/2024/81).
