For ADS vehicles, specific testing scenarios should be developed to verify compliance of different braking systems mandatory on vehicles. Dual-mode vehicles should be tested in both modes.

R78	To be determined by detailed screening	Applicable. Similarly to R13 and R13H, R78 should be applicable to ADS vehicles in regards to vehicle categories L6 and L7. If ADS technology is implemented on L5 category vehicles, these vehicles also should be included into the scope of modified provisions.

R79 includes the provisions for reliability of vehicle steering and the provisions for some automatically commanded steering functions. Only the limited number of provisions for reliability of vehicle steering is applicable for ADS vehicles. When deciding on actualization of R79 for ADS vehicles, consider copying applicable provisions from R79 to the specific ADS UN Regulation, so that R79 would remain unchanged. However, R79 should be applicable to dual-mode vehicles.
