Integrated Document: Status and Planning

- Sep 2023: Sections 1-3 sent to FRAV and VMAD, discussion in FRAV and VMAD
- Oct 2023: Sections 1-3 updates per FRAV/VMAD comments, draft of sections 4-8 sent to FRAV and VMAD
- Nov 2023: Feedback from FRAV and VMAD on revised sections 1-3 and first drafts of sections 4-8, preparation of next versions for Integration Document for the combined FRAV/VMAD session in Dec.
- Dec 2023: Discussion first complete Integration Document in combined FRAV/VMAD; freezing date for FRAV and VMAD documents (exceptions only after approval of responsible co-chairs)
- Jan 2024: Integration comments from December FRAV/VMAD/IG, status report in January GRVA, if possible in week 3, distribution of draft Integration Document as informal to GRVA
- Feb 2024: Translation of updates from FRAV and VMAD between September resp. June and December into Addendum for the Integration Document
- Mar 2024: distribution last iteration Integration Document and the Addendum to FRAV and VMAD
- Apr 2024 week 14: acceptance Integration Document plus the Addendum in FRAV and VMAD, distribution to GRVA
- May 2024: acceptance formal Integration Document in GRVA, acceptance informal Addendum
- Jun 2024: informal Integration Document plus Addendum in WP.29, after WP.29 translation of these two documents into one formal document for the November WP.29

- Secretariat prepared consolidated table of text and input received.
 - Column 1 contains the draft text.
 - Text considered accepted (green) unless proposal to change received.
 - Text subject to proposals highlighted in yellow.
 - Column 2 contains proposals and comments.
 - Proposals for changes in yellow.
 - Additional comments for consideration in red text.
 - Column 3 reserved for recording discussion and decisions.
 - Table omits hierarchy (numbering) due to different approaches in original drafts.
 - FRAV/VMAD should reach a decision on how to handle structure.
 - Table omits text of annexes
 - Insufficient time for preparation—will be added before Tokyo session.
- Updated table and draft clean text of submission will be prepared for Tokyo session.
