Meeting Minutes

Agenda Item 1: Welcome and introduction

The chair welcomed the participants and proceeded to the first point on the agenda

Agenda item 2: Adoption of the agenda

The agenda was approved by the participants.

Agenda item 3: Adoption of the last meeting minutes

The last meeting minutes have been approved.

<u>Agenda item 4: SG6 Guidelines – quick review of last meeting</u>

The chair quickly reviewed the open points of discussion in the latest version of the Guidelines.

- JRC commented that the decision on the GHG species at the IWG is not clear at all. The

chair considered raising the issue to IWG.

- The chair confirmed that the IWG agreed that the SG's may consider all species based on relevant arguments why these should be included.
- NGVA asked about the meaning of Cut-off point of 5%. JRC, ICCT, and Ricardo mentioned that the number is a temporal value that includes from the experience and guesses.
 - o In order to minimize the risk of excluding collectively to much from the methodology, both ICCT and Ricardo argued in favor of a method where you only exclude the marginal emissions. With the understanding that this is quite hard as you never now the total emissions.
 - o JRC underlined that it should not be more than 5% of the total emissions.
 - The SG agreed that this should be better defined and that we will for this to an existing methodology (as suggested by Riccardo) based on proxies and best estimations.
- There were discussions on the category of infrastructure by different participants. In addition, the inclusion of transport (plane, ship, train, ...) were raised by one participant.

Agenda item 5: Levelling Concept (proposal)

The chair decided that the proposal is postponed.

Agenda item 6: Indirect Land-Use Change

ICCT, JRC, Ricardo are requested to present their positions at the near future IWG by the chair.

- It was agreed that the Chair will inform the A-LCA leadership about this and that this should be presented during the upcoming IWG.
- The SG agreed that excluding ILUC would be wrong and therefor agreed that some type of methodology and measurements should be included.

Agenda item 7: Division of tasks Carbon feedback, allocation and co-products

CARBON FEEDBACK: JRC will check to what extent this is already included in AR6. If this is the case, the SG does not has to tackle this in the overall aspects.

FUTURE OUTLOOKS: the members disagreed about the necessity of including this into the methodology.

Due to lack of time, the other topics were not discussed. The chair asked to the participants to raise the proposal if the participants have an idea.
