#### ADS Status of work

- First session (22 April) reviewed initial deliberations and expectations
  - WP.29 agreed to establish ADS informal group under GRVA to draft UN GTR and UN Regulation on ADS safety.
  - WP.29 directed GRVA to hold workshops for development of aspects specific to GTR and UNR.
  - Set June 2026 session for concurrent adoption of GTR and UNR (effectively sets deadline of 31 October 2025 for IWG completion of proposals)
  - GTR and UNR to be based on the ADS guidelines and recommendations as approved by WP.29 during its June 2024 session (WP.29/2024/39 subject to amendments/addendum)
- Introduced IWG leadership
  - Chairs: Canada, China, European Commission, Japan, United Kingdom, United States of America
  - Liaison ambassadors for IWG-GRVA workshop coordination: Australia, Netherlands
  - Secretariat: AAPC, JASIC, OICA, SAE



#### S Status of work

- Presented draft structural framework (ADS-01-03)
  - Providing main elements of GTR and UNR and supporting documents (GTR appendix, guiding/interpretation document, etc.)
  - Noting elements specific to GTR or UNR
  - Indicating areas of primary responsibility between ADS IWG and GRVA workshops
  - Noted sections on "General requirements", "Performance requirements/Test specifications", and "Assessment/Test procedures" to be elaborated for 2<sup>nd</sup> session.
- Explained IWG internal methodology for completing work
  - IWG sessions roughly every 2-3 months
  - Volunteers to serve as "officers of principle interest" (OPI) to prepare draft content and act as points of contact to consolidate input from experts.
  - Phased development with defined OPI tasks for work between sessions.
  - Initial objective to transpose guidelines into draft regulatory requirements.



#### S Core document starting point\*

- ADS-01-03 provided initial breakdown and allocation of GTR/UNR contents.
- ADS-02-03 elaborates the main sections of concern to the IWG
  - Safety Management System
  - ADS performance of the DDT
  - ADS interactions with user(s)
  - Manufacturer's Safety Assessment
  - In-Service Monitoring and Reporting
- The general requirements correspond to more detailed requirements and specifications.
- The requirements are linked to the assessment/test methods and annexes.

<sup>•</sup> The deliverables are a GTR and UNR. The document is a tool for developing the provisions and identifying open issues and further needs before attempting to draft GTR and UNR proposals. It is a first phase of work to translate the guidelines into regulatory provisions and address any gaps or ambiguity to enable efficient transposition into GTR and UNR texts at a later stage.




#### Initial objectives, tasks, and OPI

- 1. List of existing standards, regulations, etc.
- 2. Monitor work for recommendations outside scope of the regulations
- 3. Safety Management System general and specific requirements
- 4. DDT performance general and specific requirements
- 5. ADS user interactions general and specific requirements
- 6. ADS Safety Assessment general and specific requirements
- 7. ISMR general and specific requirements
- 8. Testing: Virtual testing credibility assessment requirements

Coordination for provisions relevant to CS/OTA, EDR/DSSAD, AVC, and FADS will be handled by the ADS IWG leadership.



#### Overview of initial text development





#### OPI role and responsibilities

- Temporary mandate linked to the duration of the task(s)
- Free to organize the work (experts, meetings, etc.)
- Editorial translation of guidelines into draft requirements
  - Cosmetic changes so "recommendation" reads as "requirement"
  - Keep proposals for open issues or substantive changes separate from initial translation.
- Provide proposals to open items for discussion, if any
  - Aim to consolidate an "open issues" list to guide future meetings and tasks
  - Particular attention to clarity (i.e., does text need clarification or further explanation?)
- Provide proposals to amend draft requirements, if any.
- Deliver draft text for requirements by 10 June.
- Report back to co-chairs and ADS IWG during the 3<sup>rd</sup> session.

#### Next tasks: Address assessment/testing

- Initial aim to discuss draft requirements (sections 4-5 in ADS-02-03) during the 3<sup>rd</sup> (July) session.
  - Desired outcome to have a clear sense of requirements and any interests in clarifications or amendments, including needs specific to GTR and UN Regulation.
  - Based on the discussions, further tasks might be identified to generate input for the next session.
  - The 4<sup>th</sup> (October) session would include further elaboration as warranted.
- Next step to transpose assessment/testing guidelines into working document.
  - Same general approach: translation plus open issues/proposals.
  - Attention to links between requirements and methods (e.g., audit of SMS).
  - OPI volunteers will be solicited in July to cover methods (audit, virtual testing, track testing, real-world testing, safety assessment review, etc.).
  - Deadline for input: 16 September (4<sup>th</sup> session 8-10 October).



## ADS Draft working document (ADS-02-04)

- The internal IWG working document is a table.
  - Current text in the left column.
  - Comments and proposals submitted for a session in the middle column.
  - Space for recording session discussions in the third column.
- ADS-02-04 provides initial translation text for the scope, purpose, and definitions.
  - Proposals for purpose and scope, noting that GTR and UNR would have differences.
  - Definitions copy/pasted from ADS guidelines (WP.29/2024/39).
  - Comments and proposals from experts are welcome for consideration during the 3<sup>rd</sup> session.
  - The OPI for these sections is the IWG secretary from AAPC.
