#### 5. Discussion

#### Feedback last WP.11

#### Electrification – after the proposal for the guidance, how and where

It was discussed at last WP.11 session that although INF 12 contained a good basis it should not be guidance but introduced in the annexes of the regulation itself. It is however not so clear where to place such a text. It was suggested that Annex 1 article 3 could be considered, a new section or chapter in Annex 1 specific for electric drive or a part on dimensioning of modules. Participants were asked to think about this for the next session.

# Partitions - How to proceed

It was recalled that several documents were discussed at the last session of WP.11, proposing definitions and as an alternative as text for provision. It was questioned how to proceed on this, would it be wider for all equipment, for example limiting the size of a compartment?

The discussion concerning "removable" in the light of "not fixed" between France and Spain was mentioned. In Spain "not fixed" was used as to be taken out of the body to make cleaning easier, not that partitions were left out of the equipment. A solution could be to link the body and partition(s) by markings.

Soft partitions were also discussed if a differentiation could be could be considered for packages foodstuffs and non-packaged (contamination).

#### **Interpretation of Special equipment <-> equipment**

It was questioned during the last WP.11 whether the two terms had different meanings. In particular in the light if the energy source, fuel tank, battery or fuel cell is included in de term "equipment". It was felt that "equipment" was a short for "special equipment". No conclusion could be reached.

#### **Temperature recorders**

The discussion is if a recorder should be included in all FRC equipment. In Germany and a limited number of other countries it is a requirement to have the recorder fitted in order to have an FRC certificate. Other countries do not require this. As the requirement is in Annex 2, and only for quick-frozen foodstuffs. However, no consensus could be reached.

#### External width of ATP vehicles with 45 mm walls

[Equipment with 45 mm thick walls are allowed to a greater vehicle with of 260 cm rather than 255 cm. Currently this is limited to heavily insulated equipment, but why should this not be for normal insulated equipment as well. If this is limited declassification in use will be problematic. No conclusions were reached.]

# **Restructuring Annex 1**

- The idea is to establishment of a drafting group with a limited number of participants for restructuring. This was not finalized during the session.

#### ITC high level statement on climate change – avoid-shift-improve.

- The chair mentioned the obligation coming from the UNECE-ITC for working parties to consider measures to lower the environmental impact. Several suggestions were given by the chair to work on this, noting that for the ATP depended on other parties (Fgases/NRMM). It was remarked that the ATP dealt with food safety rather than environmental impact.

# Development of a white paper

The topic of a white paper to develop an inventory for future development was presented. No actions were taken at this session.
(Development in foods, trade, transport, insulation, refrigeration, refrigeration media, etc)

- The question was raised on national inspection bodies that verify thermal appliances according to Annex, appendix 2 part 6. No conclusions were drawn.
