1. Welcome

The Chairman, Mr Rovers welcomed the participants and thanked Mr Hostens and CEMA for the invitation and the hosting of the meeting. He opened the meeting at approx. 10:30 hrs.

2. Introduction of participants

The participants introduced themselves (see also Document AVLI 06-07).

3. Adoption of the Agenda (Doc. AVLI 06-02e)

The agenda was unanimously adopted.

The headline of agenda item 4 was modified as follows:

"Further development of requirements regarding cat. R and S: Continuation of the discussion of the comments received on document AVLI 05-01e and **AVLI 05-01e Rev 1** (Doc. AVLI 05-05e **Rev 3**)"

The running order of the meeting was determined as follows:

- a) Continue discussion starting from paragraph 6.26 until Annex 6
- b) Discussion of the outstanding items 6.18.1 and 6.21
- c) Discussion of the new comments (indicated in green letters in AVLI 05-05e Rev 3)
- d) Discussion of Chapter 12 (Transitional Provisions)

4. Further development of requirements regarding cat. R and S: Continuation of the discussion of the comments received on document AVLI 05-01e and AVLI 05-01e Rev 1 (Doc. AVLI 05-05e Rev 3)

The discussion continued with a review of the comments received, as in AVLI 05-05e Rev 3. AVLI Secretariat received additional comments from CLEPA (AVLI 06-03e Rev 1) and CEMA (AVLI 06-04e) which have been included in AVLI 05-05e Rev 3 and distributed to IWG AVLI on 2015-01-16. The conclusions are summarised in AVLI 05-05e Rev 4. Document AVLI 05-05e Rev 4 is a substantial part of the report.

AVLI Secretary prepared a first draft for the "Transitional provisions". This document, AVLI 06-05e, was shortly discussed and the participants came to the unanimous result that a transitional period of 24 months (after the official date of entry into force of the 01 series of amendments of R 86) is acceptable and therefore the [] were deleted (see AVLI 06-05e Rev 1). AVLI 06-05e Rev 1 was also included in AVLI 05-01e Rev 2

The question whether an additional transitional provision clause is needed by the EU for the case that Contracting Parties may refuse the first registration or entry into service for new vehicles as from a certain date (e. g. 48 months after the official date of entry into force) will be checked by the European Commission. If so, the European Commission will inform AVLI appropriately.

It was agreed that the decisions taken during the meeting will be included in a revised document to become AVLI 05-01e Rev 2. The content of this document shall be submitted as an informal document to GRE to be discussed during its 73rd session.

5. Planning of the further steps and meetings

AVLI secretary will prepare the revised working document, AVLI 05-01e Rev 2.

ETF will finally check the document. It will be submitted as an informal document to GRE for discussion at the 73rd GRE-Session (from 2015-04-14 to 2015-04-17). This informal document (to become GRE 73-02e) will show the entire text of R.86 but will highlight only the issues amended in Phase II (i. e. green markings only, the yellow ones will disappear as they are already adopted by GRE).

A tentative date for the 7th meeting of IWG AVLI, if necessary, was determined for 2015-06-16 in the Frankfurt area, starting at 10:30 hrs. This will depend on the result and the probable advice from GRE.

The 3rd meeting of the Editorial Task Force (ETF) will be held in the Frankfurt area on 2015-06-17 (NB: only for ETF members). The ETF consists of: Derwin Rovers (Chair AVLI), Gerd Kellermann (Co-Chair AVLI), Andreas Schauer (Secretary AVLI), Timo Kärkkäinen (SF), Stefano Pagliarani (IT) and Ivo Hostens (CEMA).

6. Any Other Business

The EU Commission made some comments on deviations between AVLI 05-01e Rev 1 and the adopted version of RVFSR. As the IWG AVLI recommends that the Commission should not amend RVFSR at that stage, no further action is required at the moment for AVLI.

7. Closing

At the end of the meeting, the Chairman, Mr. Rovers, thanked Mr. Hostens again for kindly hosting this 6th session of 'AVLI' and the secretary of IWG 'AVLI' for all his good work in preparation and execution of the meeting. Finally, he thanked all the participants for their good cooperation and the fruitful discussions.
