	the solar / wind PPP specifics, but also encompass broader regulatory and political factors. Regarding the Public Sector Work Stream, it was noted that sufficient input from the public sector representatives was essential for the credibility and comprehensiveness of the PPP standardization. It was stressed that a PPP process is similar in all sectors so if project group members do not have specific renewable energy PPPs experience they should nevertheless still feel free to contribute to this process by, for example, providing input on the relevant public sector procurement considerations, legal and regulatory framework considerations. Furthermore, input was needed for understanding how PPP helped to deliver value for money. It was agreed that the questionnaire should be structured in a way that it would not take more than 15 – 20min to respond. It was discussed in how far the questionnaire should be personalized to the background of participants and it was decided to postpone this decision for after completion of the questionnaire.
