- Informal proposal presented at GRPE (June 2015)
- EPPR-12-21e = working draft GTR version 8.1 = EPPR group document based on proposal by the EC and amendments proposed by other stakeholders
- Draft compromise solutions for most of the issues
- Review Part A
- Proposal for Technical Report for review
- Target:
 - Formal proposal in time for GRPE (Jan 2016),
 - Deadline: 19 Oct 2015

State of play

OBD-I

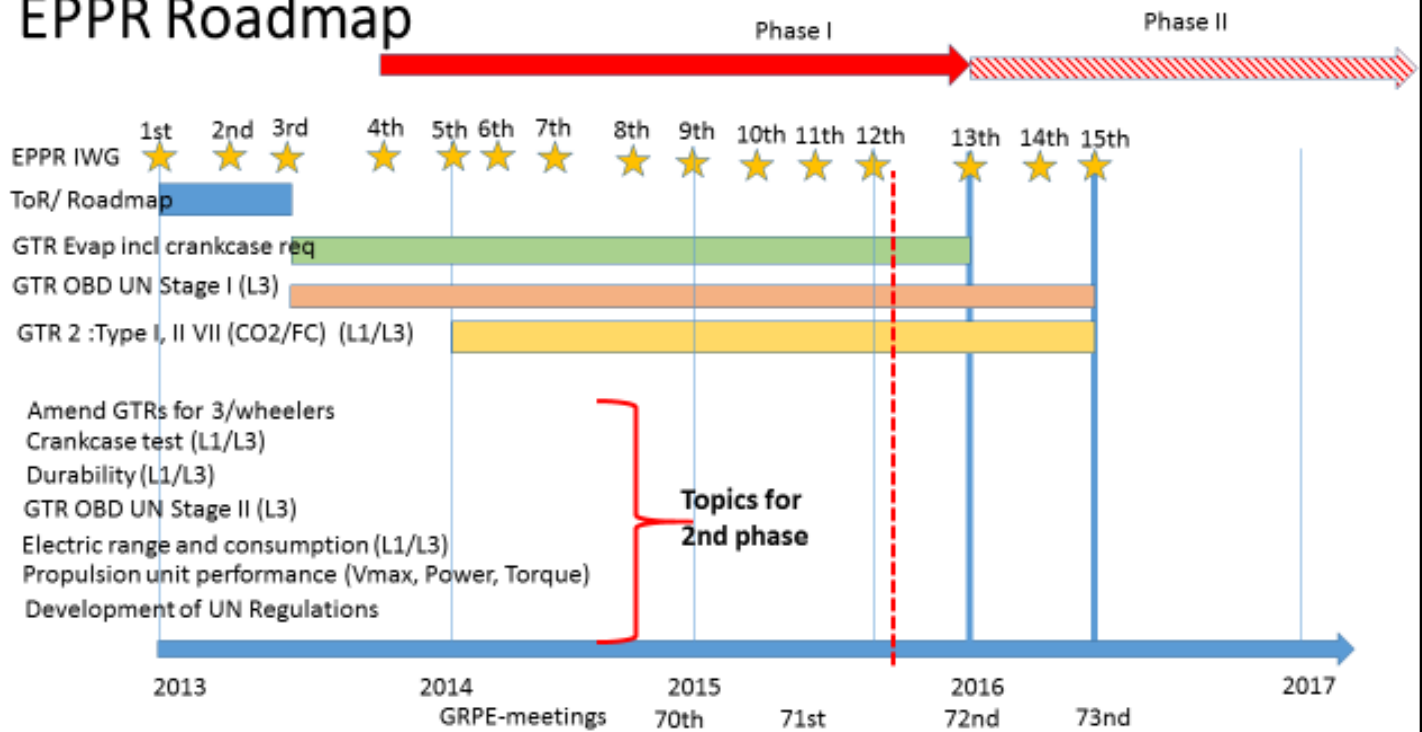
- EPPR-10-17 = working draft GTR version 2 = EPPR group document based on proposal by the EC and amendments proposed by other stakeholders (mainly Japan)
- Open Issues:
 - Japan (EPPR-12-08):
 - Compromise on MI activation criteria and related test provisions
 - 3 main issues remaining:
 - objective of OBD is environmental protection
 - Access to OBD information
 - Administrative provisions
 - India (EPPR-12-14):
 - 58 amendment proposals
 - Split OBD-I into 4 classes: A-B-C-D
 - Class A = List of 9 sensors and actuators to be monitored for electric circuit malfunctions, open/short circuit failures

State of play

GTR2

- EPPR-11-15 Rev1 = proposal EC
- IMMA started identification of differences with current GTR2 = EPPR-11-10
- Extensive document → split the work, during 2016

EPPR Roadmap



- Extension of EPPR mandate 2016 – 2020 approved by GRPE and WP.29
- Need for drafting coordinator
