I realize from reading at the internet that you accepted my proposal for a consolidated proposal document as being appropriate. That was good to see. Then I raise a new question with you.

As you probably remember at the 79th session of the GRRF we had a proposal for the multi-vehicle couplings regulations as the document attached. We will work with this document at our next meeting in the working group. **In this context I have a question to you what would be the best way to proceed? I would also ask you to consider the request that you have put to the group to put the regulation 55 into a new typeface (Not courier) according to the WP29 guidelines.**

What I am thinking in this way. As the new annex proposed in the attached document is a rather large change and the that the new type face is a rework of the regulation text all together perhaps one shall consolidate and start a new series of amendments? What is you recommendation?

Personally I very much like the structure of the attached documents as it makes it much easier to handle different issues coming up also in the future.

If you think consolidation is a good idea I am prepared to sent you a proposal during next week such that you could give me some feedback before the working group meeting 20th – 21st of October.
