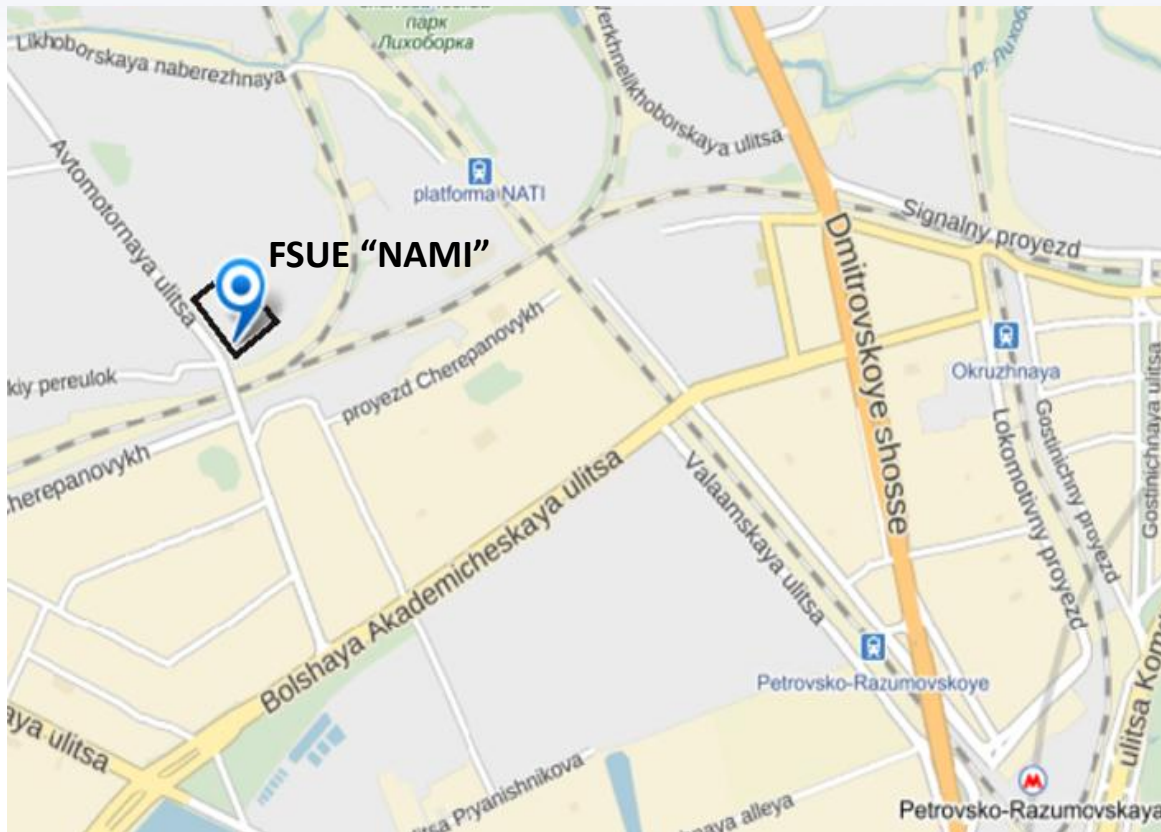


## 12th AECS meeting (9-11 February 2016) - General information

For your convenience the special bus transfer for AECS participants will be arranged from st. Petrovsko-Razumovskaya to the meeting place (FSUE “NAMI”).

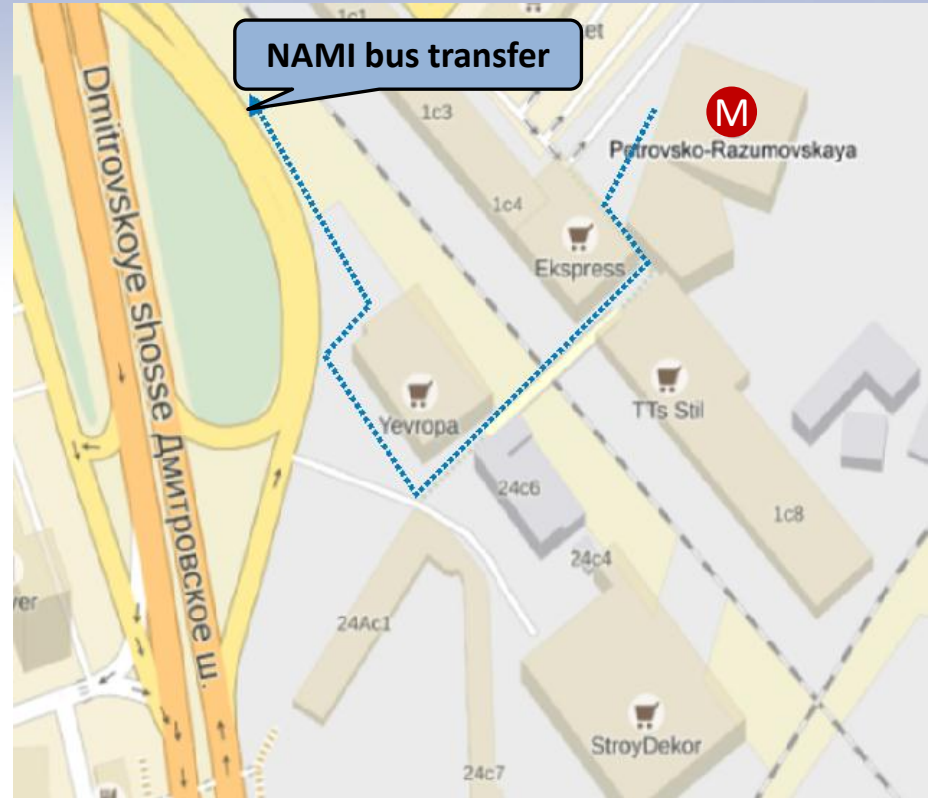
