- If cat T vehicles should be implemented, corresponding figures have to be implemented.

- A proposal prepared by OICA is discussed.
- o Spain and France agreed to this proposal

OICA 39

- A proposal prepared by OICA regarding surges (Annex 16; Clause 1.2) which needs some precision.
- Spain and France agreed to this proposal

OICA 40

- A proposal prepared by OICA regarding z-folding of DC charging cables (Annex 4 §2.6; Annex 6 §2.6) which needs some addition because of problems with large diameter charging harness.
- Spain and France agreed to this proposal

Italy 1

- From 5th meeting: Roadmap: Proposal about currents will be delivered by Italy to be discussed and included in July's final working paper (Action Item 5-2, Italy)
- Decision that the proposal to add the sentence "In case of multiple batteries the average state of charge must be considered" is sufficient to consider Italy1 comment (decision confirmed by the email from Mr Savio of May 22nd).

- Annex 4; Figure 1 Discussion, if an additional sentence should be added / copied from CISPR12.
- Because in ECER10-05 in Annex 4 §1.2 CISPR12 is already referenced, the 3m test method for long vehicles is described sufficient.
- o The participants agreed, NOT to add any sentence

New: UTAC16 (UTAC 6 in document TF-EMC-06-04)

- Discussion about the change of China 4 regarding changing the midpoint of the engine to the midpoint of the vehicle.
- Is this change also necessary for the motor cycle
 The participants agreed, for motorcycles there is no a change the midpoint of the engine to the midpoint of the vehicle necessary because of the length of the vehicle

• Discussion about additional T.P.s for "sundown of ECE-R10-04"

- Until the meeting, no proposal was delivered.
- Decision: OICA will prepare a proposal based on §13.4 and sent it to the CPs for further discussions in the 7th meeting TF EMC.
