**ESTABLISHMENT OF AMENDMENT 2
TO GLOBAL TECHNICAL REGULATION No. 1**

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 21 June 2017, at its fiftieth session, the Executive Committee of the Agreement established the following amendment in the Global Registry, under the symbol ECE/TRANS/180/Add.1/Amend.2, by consensus vote (ECE/TRANS/WP.29/1131, para. 118), in accordance with para. 7.2. of article 7 of Annex B to the Agreement:

Amendment 2 to global technical regulation No. 1 on door locks and door retention components (ECE/TRANS/WP.29/2017/97).

The following documents are appended to Amendment 2 of global technical regulation No. 1 under the symbol ECE/TRANS/180/Add.1/Amend.2/Appendix 1:

Authorization to develop Amendment 2 to the gtr No. 1 (Door locks and door retention components) (TRANS/WP.29/AC.3/43).

Final report of proposal for Amendment 2 to global technical regulation No. 1 (Door locks and door retention components) (ECE/TRANS/WP.29/2017/96).

Reference is made in this respect to paragraph 6.4. of the 1998 Agreement on the process for amending global technical regulations, as well as paragraphs 7.1. to 7.6. of the 1998 Agreement on the adoption and notification of application of global technical regulations.
