### ESTABLISHMENT OF AMENDMENT 1 TO GLOBAL TECHNICAL REGULATION No. 4

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 12 November 2009, at its twenty-seventh session, the Executive Committee of the Agreement, in accordance with para. 7.2. of article 7 of Annex B to the Agreement, established by consensus vote (ECE/TRANS/WP.29/1079, para. 93) the following draft amendment:

Amendment 1 to global technical regulation No. 4 (Test procedure for compression-ignition (C.I.) engines and positive-ignition (P.I.) engines fuelled with natural gas (NG) or liquefied petroleum gas (LPG) with regard to the emission of pollutants) (ECE/TRANS/WP.29/2009/121).

The above amendment was established in the Global Registry as Amendment 1 of global technical regulation No. 4, under the symbol ECE/TRANS/180/Add.4/Amend.1.
