ESTABLISHMENT OF AMENDMENT 1 TO GLOBAL TECHNICAL REGULATION No. 5

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the 1998 Agreement, communicates the following:

On 15 November 2012, at its thirty-sixth session, the Executive Committee of the Agreement established the following amendment in the Global Registry, under the symbol ECE/TRANS/180/Add.5/Amend.1, by consensus vote (ECE/TRANS/WP.29/1099, paras. 94 and 95), in accordance with paragraph 7.2. of Annex B to the Agreement:
