The Permanent Mission of Japan to the International Organizations in Geneva presents its compliments to the Executive Secretary of the United Nations Economic Commission for Europe and, with reference to Japan's submission of the status report on the regulations annexed to the AGREEMENT CONCERNING THE ESTABLISHING OF GLOBAL TECHNICAL REGULATIONS FOR WHEELED VEHICLES, EQUIPMENT AND PARTS WHICH CAN BE FITTED AND/OR BE USED ON WHEELED VEHICLES done at Geneva on 25 June 1998, has the honor to submit the following status report regarding Global technical regulation (hereinafter referred to as the "UN GTR") No.4 and its Amend. 1, UN GTR No.5 and its Amend. 1 and UN GTR No.14 in accordance with Article 7.4 of the abovementioned Agreement.

UN GTR No. 4 and its Amend.1, TEST PROCEDURE FOR COMPRESSION-IGNITION (C.I.) ENGINES AND POSITIVE-IGNITION (P.I.) ENGINES FUELLED WITH NATURAL GAS (NG) OR LIQUEFIED PETROLEUM GAS (LPG) WITH REGARD TO THE EMISSION OF POLLUTANTS

Japan has been targeting the introduction of UN GTR No.4 and its Amend.1 into the Road Vehicles Act by 2016, and verifying and confirming the details of such test procedures.

UN GTR No. 5 and its Amend.1, TECHNICAL REQUIREMENTS FOR ON-BOARD DIAGNOSTIC SYSTEMS (OBD) FOR ROAD VEHICLES

Japan has been targeting the introduction of UN GTR No.5 and its Amend.1 into the Road Vehicles Act by 2018, and verifying and confirming the details of such requirement.

UN GTR No. 14.

POLE SIDE IMPACT

Japan will incorporate UN GTR No.14 into its national legislations through the application of the corresponding UN Regulation which was established on November 2014 and will be adopted on June 2015, and which is annexed to the AGREEMENT CONCERNING THE ADOPTION OF UNIFORM TECHNICAL PRESCRIPTIONS FOR WHEELED

VEHICLES, EQUIPMENT AND PARTS WHICH CAN BE FITTED AND/OR BE USED ON WHEELED VEHICLES AND THE CONDITIONS FOR RECIPROCAL RECOGNITION OF APPROVALS GRANTED ON THE BASIS OF THESE PRESCRIPTIONS.
