## ESTABLISHMENT OF AMENDMENT 1 TO GLOBAL TECHNICAL REGULATION No. 9

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 10 November 2010, at its thirtieth session, the Executive Committee of the Agreement established the following amendment in the Global Registry, under the symbol ECE/TRANS/180/Add.9/Amend.1, by consensus vote (ECE/TRANS/WP.29/1087, paras. 103-104), in accordance with paragraph 7.2. of Annex B to the Agreement:

Amendment 1 to global technical regulation No. 9 (Pedestrian safety) (ECE/TRANS/WP.29/2010/134 and ECE/TRANS/WP.29/2010/134/Corr.1).
