**ESTABLISHMENT OF AMENDMENT 1
TO UNITED NATIONS GLOBAL TECHNICAL REGULATION No. 13**

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 21 June 2023, at its sixty-sixth session, the Executive Committee of the Agreement established the following draft United Nations Global Technical Regulation in the United Nations Global Registry, under the symbol ECE/TRANS/180/Add.13/Amend.1, by consensus vote (ECE/TRANS/WP.29/1173, para. 171), in accordance with para. 7.2. of article 7 of Annex B to the Agreement:

Amendment 1 to United Nations Global Technical Regulation on Hydrogen and Fuel Cell Vehicles (ECE/TRANS/WP.29/2023/81).

The following documents are appended to Amendment 1 of UN Global Technical Regulation No. 13 under the symbol ECE/TRANS/180/Add.13/Amend.1/Appendix 1:

Authorization to develop the Phase 2 of the global technical regulation (ECE/TRANS/WP.29/AC.3/49).

Final progress report on Amendment 1 to UN Global Technical Regulation No. 13, Phase 2 (Hydrogen and Fuel Cell Vehicles) (ECE/TRANS/WP.29/2023/82).
