# ESTABLISHMENT OF AMENDMENT 1 TO GLOBAL TECHNICAL REGULATION No. 15

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 17 November 2016, at its forty-eighth session, the Executive Committee of the Agreement established the following amendment in the Global Registry, under the symbol ECE/TRANS/180/Add.15/Amend.1, by consensus vote (ECE/TRANS/WP.29/1126, para. 114), in accordance with para. 7.2. of article 7 of Annex B to the Agreement:

Amendment 1 to global technical regulation No. 15 on the Worldwide harmonized Light vehicle Test Procedures (WLTP) (ECE/TRANS/WP.29/2016/68).

The following documents are appended to Amendment 1 of global technical regulation No. 15 under the symbol ECE/TRANS/180/Add.15/Amend.1/Appendix 1:

Authorization to develop amendments to global technical regulation No. 15 on the Worldwide harmonized Light vehicles Test Procedures (WLTP) (TRANS/WP.29/AC.3/39).

Technical report on the development of draft Amendment 1 to global technical regulation No. 15 (Worldwide harmonized Light vehicles Test Procedures (WLTP)) (ECE/TRANS/WP.29/2016/69).
