ESTABLISHMENT OF AMENDMENT 3 TO GLOBAL TECHNICAL REGULATION No. 15

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 15 November 2017, at its fifty-first session, the Executive Committee of the Agreement established the following amendment in the Global Registry, under the symbol ECE/TRANS/180/Add.15/Amend.3, by consensus vote (ECE/TRANS/WP.29/1135, para. 116), in accordance with para. 7.2. of article 7 of Annex B to the Agreement:

Amendment 3 to global technical regulation No. 15 on the Worldwide harmonized Light vehicle Test Procedures (WLTP) (ECE/TRANS/WP.29/2017/140).

Authorization to develop amendments to global technical regulation No. 15 on the Worldwide harmonized Light vehicles Test Procedures (WLTP) (TRANS/WP.29/AC.3/44).

Technical report on the development of Amendment 3 to global technical regulation No. 15 (Worldwide harmonized Light vehicles Test Procedures (WLTP)) (ECE/TRANS/WP.29/2017/141). Reference is made in this respect to paragraph 6.4. of the 1998 Agreement on the process for amending global technical regulations, as well as paragraphs 7.1. to 7.6. of the 1998 Agreement on the adoption and notification of application of global technical regulations.
