ESTABLISHMENT OF AMENDMENT 1 TO GLOBAL TECHNICAL REGULATION No. 16

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 17 November 2016, at its forty-eighth session, the Executive Committee of the Agreement established the following amendment in the Global Registry, under the symbol ECE/TRANS/180/Add.16/Amend.1, by consensus vote (ECE/TRANS/WP.29/1126, para. 116), in accordance with para. 7.2. of article 7 of Annex B to the Agreement:

Amendment 1 to global technical regulation No. 16 (Tyres) (ECE/TRANS/WP.29/2016/117).
