ESTABLISHMENT OF GLOBAL TECHNICAL REGULATION No. 19

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 21 June 2017, at its fiftieth session, the Executive Committee of the Agreement established the following amendment in the Global Registry, under the symbol ECE/TRANS/180/Add.19, by consensus vote (ECE/TRANS/WP.29/1131, para. 116), in accordance with para. 7.2. of article 7 of Annex B to the Agreement:

Global technical regulation on evaporative emission test procedure for a Worldwide harmonized Light vehicles Test Procedure (WLTP EVAP) (ECE/TRANS/WP.29/2017/94).

Authorization to develop amendments to global technical regulation No. 15 on the Worldwide harmonized Light vehicles Test Procedures (WLTP) (TRANS/WP.29/AC.3/44).

Technical report on the development of new global technical regulation No 19 on the evaporative emission test procedure for the Worldwide harmonized Light vehicles Test Procedure (WLTP EVAP) (ECE/TRANS/WP.29/2017/95).
