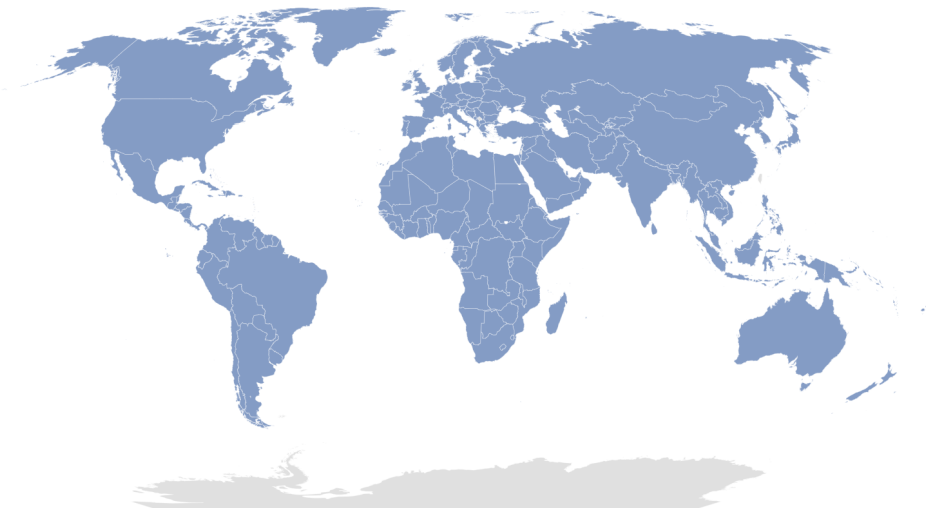


Observatory on Border Crossings Status due to COVID-19 Home
