EU Digital COVID Certificates

The 'EU Digital COVID Certificate' (EUDCC) is digital proof, valid in all EU countries, that a person has either been vaccinated against COVID-19, has recovered from COVID-19, or has received a negative test result. **National authorities are responsible for issuing the certificate.** All EU citizens and their family members, as well as non-EU nationals who are legally staying or residing in an EU country and have the right to travel within the EU, can get the EUDCC. A [list of non-EU countries and territories](#) whose certificates are accepted under the same conditions as the EUDCC is also available.

Note: although the 'EU Digital COVID Certificate' is valid across the EU, countries remain responsible for their own entry rules and health measures during the pandemic. This means that **entry requirements depend on your destination.**

As of 1 February 2022, vaccination certificates will be valid for travel purposes within the EU for a period of 9 months (270 days).

This rule also applies in establishments and facilities where a 3G certificate is required: work places, catering establishments, restaurants and bars, and cultural, leisure and sports facilities. Events with fewer than 50 persons, as well as religious events and funerals, are not subject to the certificate requirements. Private events are completely exempt from the certificate obligation.

Use of facemasks

Face masks must be worn in all indoor areas and including public transportation.

Physical Distancing

Physical distancing of at least 1,5 meter is required for any public or working space where people don't carry masks.

Indoor and outdoor meetings, public or private gatherings and events

Events with fewer than 50 persons, as well as religious events and funerals, are not subject to certificate requirements. Private events are completely exempt from the certificate obligation.

Safety measures for public transportation

Face masks must be worn on public transportation by everyone over age 12. The rule includes mountain railways.

Places of worship

The 3G-rule is in effect. Churches and houses of worship remain open.

Quarantine

The same rules for quarantine in Switzerland apply to Liechtenstein.

Non-essential (other than medicine and food) shops

The 3G-rule is in effect. Certificates will be checked when entering the premises. Guests must eat and consume beverages while seated. This rule also applies to Advent and Christmas markets. Where possible, social distancing should be observed.

The 3G-rule is in effect. Certificates will be checked when entering the premises.

Physical distancing of at least 1,5 meter is required for any public or working space where people don't carry masks.

Indoor and outdoor meetings, public or private gatherings and events

Events are allowed as long as organisers have implemented measures to protect participants, in particular to ensure the minimum distance of 1.5 Meters. The distance requirement can be relaxed in the case of events requiring a COVID certificate from all participants proving vaccination, test or recovery. No limitations regarding number of participants for private events with friends and relatives.

EU Digital COVID Certificates

This country is already connected to the Gateway and is issuing and/or verifying at least one EU Digital COVID Certificate (Vaccination, Recovery, Test)

The [EU Digital COVID Certificate Regulation](#) entered into force on 01 July 2021. EU citizens and residents will now be able to have their Digital COVID Certificates issued and verified across the EU. National authorities are in charge of issuing the certificate.

The certificate provides a standardised recognition of the holder's status related to vaccination, recovery from Covid-19, or test result. **Despite the European Digital COVID Certificate, each country continues to be responsible for the definition of its own entry requirements and rules, which are not standardised at the EU level.** This means that what is required to enter upon presentation of this certificate, depends on the measures and entry rules in place at your destination.

Indoor public events with an audience are allowed with up to 50 people. All other indoor events with more than 10 people are suspended (with the exception of religious events, funerals or political events).

Outdoor public events are allowed with up to 100 participants.

Accompanying protection measures are mandatory.

Private events are limited to 10 people and need to follow the recommendations of the Government and the Office of Public Health regarding hygiene and contact. Likewise, gatherings of more than 10 people in public spaces are not permitted.

EU Digital COVID Certificates

The "EU Digital COVID Certificate" (available from **1 July 2021**) provides proof that a person has either:

- **been vaccinated against COVID-19** (vaccine type and manufacturer, number of doses, date of vaccination);
- **received a negative test result**, PCR or rapid antigen, with the name of the test, date and time of test, test centre and result (self-tests are not valid);
- **recovered from COVID-19**.

When travelling, holders of the "EU Digital COVID Certificate" will have the same rights as citizens of the visited Member State who have been vaccinated, tested or recovered.

The certificate provides a standardised recognition of the holder's status related to vaccination, recovery from COVID or test result. Each country continues to be responsible for the definition of its own entry requirements and rules, which are not standardised at the EU level. This means that **what you will be eligible for, upon presentation of this certificate, depends on the measures and entry rules in place at your country of destination**.

How does it work:

1. **Member States** issue a certificate automatically or upon request, which is issued either digitally or on paper, and has a QR code with an electronic signature;
2. **Citizens** store the certificate in their digital app or wallet and can use it when they travel;
3. When the **verifier** asks the citizen for the certificate, the QR code is shown and the digital signature is verified.

All travellers entering Liechtenstein from countries or regions that are defined as Covid risk areas will have to quarantine for 10 days.

As of 26.8.20, **Andorra, Belgium, Luxembourg, Malta, Monaco, Romania** and **Spain (with the exception of Canary Islands)** are defined as Covid risk areas.

Third-country nationals

Following the EU council recommendations, entry restrictions are lifted for a selection of third countries. It currently concerns: Australia, Canada, Georgia, Japan, Morocco, New Zealand, Rwanda, South Korea, Thailand, Tunisia, and Uruguay, and the EU states outside the Schengen area (Bulgaria, Ireland, Croatia, Romania, and Cyprus). China is also expected to be removed from the list in line with the EU recommendations, provided it guarantees reciprocal rights of entry to people travelling from Liechtenstein.

Travelling from Liechtenstein or returning to Liechtenstein

Currently, the following countries are exempt from the general advice against non-urgent travel abroad (unless they are defined as Covid risk areas): countries in the Schengen area, United Kingdom, Andorra, Australia, Bulgaria, Canada, Croatia, Cyprus, Georgia, Ireland, Japan, Morocco, Monaco, New Zealand, Romania, Rwanda, San Marino, South Korea, Thailand, Tunisia, Uruguay, Vatican/Holy See.

If you re-enter Liechtenstein having at any point in the past 14 days spent time in a state or area defined as a Covid risk area, you must immediately go to your home or to other suitable accommodation, where you must stay for 10 days from the day of your arrival. A list of countries and territories with increased covid-infection risks is defined and regularly updated at www.bag.admin.ch.

Rules and Exceptions

Entry restrictions have been lifted for residents of EU/EEA countries (including UK), as well as for their family members (irrespective of their nationality). Travellers that are required to go into quarantine will be notified during the flight, on board of coaches and at border crossings.
